News From the Zoning Office

The West Earl Township office has been receiving an increasing number of inquiries regarding Township residents and property owners having unlicensed, unregistered, and/or junked vehicles on their properties. When such calls are received, the West Earl Township Zoning Officer investigates and takes appropriate action when it is apparent that violations of the Zoning Ordinance exist.

Section 184-36.A.(6) of the West Earl Township Zoning Ordinance states that automotive vehicles or trailers of any kind or type without current license plates shall not be parked or stored on any street or on any residentially-zoned property other than in completely enclosed buildings. These requirements exist for the benefit of neighboring resi-

dents and property owners who do not wish to live next to unsightly properties. In addition, unlicensed, abandoned, and junked vehicles provide habitats for unwanted small animals, rats, and mice that become unnecessary and unwanted nuisances in a residential neighborhood.

A notice of violation identifies the specific violation and provides the resident and property owner with a specified period of time to remove the violation(s). If a resident or property owner fails to address the notice of violation within the time period specified, the Township may initiate a civil enforcement action before the Magisterial District Justice where the Magisterial District Justice may impose a fine of not more than \$500 plus all court costs, *continued on pg 3*

Public Libraries are Hot! Public libraries through Lancaster County are offering wireless “hotspots”!

The Library System of Lancaster County recently installed a network in all public library facilities in Lancaster County whereby users with wireless enabled laptops, personal digital assistants (PDAs) or smart phones can access the Internet, email and a host of other “online” resources such as the POWER Library. **The wireless system is currently active and library patrons with wireless capable technology may make use of the new service while visiting their public library.**



To utilize the wireless service, in addition to having a wireless laptop or PDA, library patrons must have a library card and a telephone number recorded in their patron record. Interested patrons should see their librarian for more information.

A Message From The West Earl Sewer Authority

Greetings from the West Earl Sewer Authority and its wastewater treatment plant operator, Lloyd Garnett. The Sewer Authority will be cleaning sewer lines in the West Earl Heights Development in mid-July. Church street, Cedar Avenue, Redwood Circle and Walnut Drive sewer lines will also be cleaned. This should not cause any inconvenience to residents.

Below are a few things that residents should remember:

- Don't dump cooking oil or greases down the kitchen sink.
- Keep your sewer vents and cleanouts covered with the proper caps.
- Don't flush any hard to decompose items such as paper towels, plastics or coffee grounds.
- Report any above ground sewage discharge to the Township office.
- Don't connect sump pumps or roof downspouts to the sewer system.

The Township will be starting an on-lot (septic) system maintenance program this year. Please watch for more information in up-coming newsletters.

Refuse/Recycling News



Yard waste pick up began on April 4th and will continue through October. Please refer to your Refuse/Recycling collection schedule for specific dates. Brown Kraft Bags are required for yard waste. These biodegradable bags

are available for purchase at the Township Office for \$1 each. **Woody waste** will also be picked up on these days. Each bundle of woody waste requires a green tag. Bundles should be no longer than 4 feet and no heavier than 25 lbs. Yard waste that is not properly bagged or tagged and trash that is mixed with yard waste can not be picked up. If you would like to purchase tags or brown Kraft bags, please stop by the Township office at 157 W. Metzler Road. For your convenience a tag order form is provided Below.

including the Township's attorneys' fees, incurred as a result of such action. Each day that the violation continues shall constitute a separate violation and may subject the offender to a daily fine of up to \$500.

Property owners are also responsible for maintaining their yards in a manner which does not result in excessively high grass or weeds. Section 124-2.E. of the West Earl Township Code of Ordinances prohibits the growth of grass or weeds in excess of 12 inches in height.

The Township's Zoning Officer is responsible for notifying property owners when such problems exist, encouraging the property owner to comply with the Code. If a property owner fails to maintain the property in conformance with Section 124.E., the Board of Supervisors may remove or arrange for the removal of the high grass or weeds and collect the cost of such removal, together with a penalty of twenty-five percent (25%) of the cost of the removal.

The Township is encouraging all residents and property owners to make certain that their properties do no conflict with the requirements of the Zoning Ordinance and the Township's Code of Ordinances.

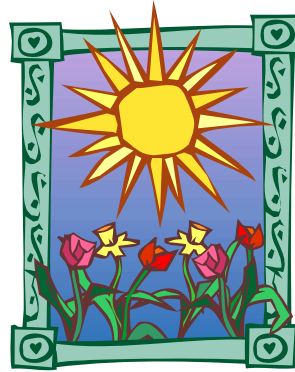
